In order to make the policy sound, we seek the deletion of 'The Retreat, Newgate Lane' as a permanent gypsy and traveller site as identified by policy DSP47. In summary, due to the proximity to our Peel Common Treatment Works, the permanent and more intensive use of the site of the 'The Retreat, Newgate Lane' is contrary to national planning policies and government guidance. This is explained further in our response to Question 5.
