Titchfield Haven is statutory designated, as follows: Titchfield Haven National Nature Reserve (NNR), Titchfield Haven Local Nature Reserve (LNR), Titchfield Haven Site of Scientific Interest (SSSI), Solent and Southampton Water Special Protection Area (SPA), Solent and Southampton Water RAMSAR. Also, non statutory sites: Sites of Importance for Nature Conservation (SINCs). It is called Thatchers Coppice SINC.

The village is situated in a valley and has within it some of the Titchfield Canal Site of Importance for Nature Conservation (SINC). The canal path running alongside the Titchfield Canal, from the village to the Meonshore, adjoins Titchfield Haven. Titchfield Haven supports internationally and nationally important populations of wading birds and wildfowl, and is designated as a Site of Special Scientific Interest (SSSI), National Nature Reserve (NNR), Local Nature Reserve (LNR), and also forms part of the Solent and Southampton Special Protection Area and Solent and Southampton Water RAMSAR because of this. In addition, Titchfield Haven and the Titchfield Canal SINC also support a many notable and protected species such as Water Voles and European Otters. Within the area there are a number of other Sites of Importance for Nature Conservation (SINCs), including Bridge Street Meadow SINC.
