Southern Water is the statutory water and wastewater undertaker for Titchfield, and as such supports the ambition of Policy BE2 to assess and consider water efficiency in new development. Efficient use of water is particularly important in the south east of England which is identified as an area of serious water stress, in addition to having the pressures of both population growth and climate change on water resources. Southern Water promotes efficient use of water as part of a twin-track approach of managing demand for water, including leakage reduction, as well as providing additional resources. This twin-track strategy aims to minimise the volume of water taken from the environment. We would encourage water efficiency measures that exceed the minimum requirements of the current Building Regulations. This would complement our own efforts to achieve greater water efficiency in an area classified by the Environment Agency as seriously water stressed. We take this opportunity to point out that the planning authority would need to ensure compliance with Building Regulations and planning policies. Water companies do not have the required enforcement powers.
