

### Why are we having a Governance Review?

- Petition from 332 electors (221 homes)
- Want own Parish Council
- Requested Governance Review





### What is a governance review?

#### Governance should:


- Reflect identities and interests of the community in that area
- Be effective and convenient



### What is a governance review?

#### We need to consider:

- Impact on community cohesion
- Size, population and boundaries
- Benefits/drawbacks





### **Options**

Option 1 - To create a new Parish Council

Option 2 - To make no changes to the current arrangements

Have your initial say by 14 December



### What can Parish Councils do?

- Own land, maintain green spaces, parks, play areas, burial grounds and allotments
- Repair and maintain footpaths and cycle paths
- Own, provide and equip community centres



### What can Parish Councils do?

- Spend money on crime prevention and traffic calming
- Provide public toilets, bins, bus shelters and parking spaces
- Statutory consultee for comments on planning applications in their Parish but not able to decide them



### How are Parish Councils run?

- Elections every 4 years
- Funding:
- Precept paid for by villagers only
- Additional to Council Tax bill




## Example costs

- Maintaining Funtley recreation ground. Ongoing cost of £1,640 per year.
- Replacing worn out outdoor items e.g. seating or bins.
  Occasional cost of e.g. £500 for seating.
- Replacing and updating children's play area. One off cost of around £70,000.

### Are there any other options?

#### **Parish Meeting:**

- May be applicable for small communities
- Meet twice a year
- Elected Chairman and trustees
- Cannot charge a precept
- Range of possible functions
- May take steps to protect parish property



### What happens next?

September- December: 1st phase consultation

January-March: Analyse responses

March-May: Pre-election period

May-June: Consult on draft recommendations


June 2016: Report and final decision
