Notice is hereby given, in accordance with the above Regulations, that Fareham Borough Council has submitted both the Fareham Borough Local Plan Part 2 'Development Sites and Policies' and the Local Plan Part 3 'The Welborne Plan' to the Secretary of State for Communities and Local Government on 23 June 2014 for independent examinations.

All submission documentation for both the Development Sites and Policies Plan and the Welborne Plan will be available to view online at www.fareham.gov.uk/planning from Friday 27 June 2014.

The submission documents for both plans comprise of the following;

- Publication Plan;
- Schedule of proposed minor modifications to the Publication Plan;
- Submission Plan (incorporating proposed minor modifications);
- Sustainability Appraisal;
- Regulation 22(1)(c) Consultation Statement;
- Duty to Co-operate Statement;
- Evidence Base.

Copies of all representations made in relation to Local Plan Part 2 or Local Plan Part 3 under Regulation 20 of the Town and Country Planning (Local Planning) (England) Regulations 2012 will also be available to view at www.fareham.gov.uk/planning from Friday 27th June.

Both the Development Sites and Policies Plan and the Welborne Plan will now be subjected to independent examination by the Planning Inspectorate on behalf of the Secretary of State. Part of the examination process will involve hearing sessions on both Plans, where those invited to attend by the appointed Planning Inspector will have the opportunity to respond to matters that are raised by the Inspector. The hearing sessions are anticipated to take place during the autumn. Once details of the examination process for both Plans are confirmed these will be made available online at www.fareham.gov.uk/planning and sent to those who submitted representations on either Plan.
