Chapter 10 correctly identifies the problem that motorised traffic causes the village but, I would argue, could be much more radical in its proposals for a solution.

Titchfield enjoys a context that very many villages and small towns would delighted to share; it has relatively short, 360 degree road access around the entire village centre. It is therefore perfectly positioned to shut its village centre to motorised traffic and reclaim its core as a welcoming place for people to enjoy. The square could be rendered largely traffic free and made level access for pedestrians, wheelchair users, parents pushing prams and the elderly with mobility frames. Parking is available barely a minute's walk from the square and the only vehicles that need to enter the square are the disabled, residents loading/unloading at their properties and delivery vehicles.

The plan rightly identifies a desire line for cycling between the village and the beach. Providing such would benefit both village residents wishing to go to the coast and would attract cycling visitors to the village where they might spend their money thus supporting local business. However, the NP offers no realistic solution. The need for a cycling route other than Posbrook Lane is evidenced by the fact that people already ignore the footpath status of the canal route and cycle there. Unfortunately, the consultation exercise asked only whether the pedestrian only status of the canal route should continue. It gave no option for respondents to say that they would like this route to be improved to make it suitable for both walking and cycling (and, indeed, wheelchairs and pushchairs.) It was thus a loaded question and no conclusion can be drawn from the responses. In face, relative to other question, very few people responded to this question and so it might be more realistic to construe that support for keeping it pedestrian only is weak.

There is no 'one-size-fits-all' solution for cycling. A family, out on their bikes, needs somewhere quiet and safe. The commuter wants to keep moving. Fortunately, there are two routes to the sea and both could be improved to the benefit of both types of cycling. Traffic calming along Posbrook Lane could improve this route for the cycle commuter (and make it less attractive to rat-run traffic bringing wider benefit to Titchfield.) Widening and better surfacing along the canal route would make it safe for a broad range of use including pushchairs and wheelchairs as well as leisure cycling. This could be done in a way that does not encourage cycling at speed.

The map identifies various cycle routes in adjacent districts but shows only one addition within the NP area. This is not joined to any of the existing routes. A key opportunity of the NP is to propose new/improved routes to make walking and cycling more attractive and hence persuade people away from the use of motorised vehicles, especially for short journeys. This has the dual benefit of reducing congestion/parking and improving health.
