It would be too lengthy to complete a new page for each paragraph, so I hope my overall comments are acceptable. I oppose the neighbourhood plan (NP) developed by the Neighbourhood Forum. For the past 50 years the Titchfield Village Trust (TVT) has satisfactorily looked after the interests of the village and continues to do so. In fact some of the NP ideas are already being taken care of by the TVT. I cannot understand why it is necessary to create an artificial boundary for Titchfield which is not the Parish boundary. Neither can I see the need for a separate land development plan when we already have the Local Borough plan. As far as I am aware, the Local Borough plan does not foresee any immediate future building in the village whereas the NP cites a significant number but offers no proposals for where those buildings might be erected. With regard to parking, Titchfield is fortunate to have the large, community car park. The TVT did liaise with local businesses to encourage them to ask their staff to use the car park rather than residential Streets. Unfortunately, that seems to have fallen on deaf ears. But in spite of that, I would oppose introducing residents parking permits, which would add yet another tax to bear. Finally, I do not see the need for Titchfield to have two organisations looking after our interests. The TVT is well supported, has done a sterling job for the past 50 years and we have no need of an additional small group of 25 self appointed people. And I would certainly resist their proposal to transform the Neighbourhood Forum into a Parish Council.
