Titchfield Village to Titchfield Haven ( Meon Shore via Canal Path ). We believe an upgraded path should be usable by walkers / ramblers, wheelchair users and cyclists as a shared facility. We recognise that Posbrook Lane which carries considerable volumes levels of traffic is unsuitable for any of these user groups. We feel that it is highly unlikely that funding would be available to upgrade this road for shared usage. THUS upgrading the canal path for shared usage is the best option for all groups. In general, where possible, we consider that walkers / ramblers, wheelchair users and cyclists should have shared use facilities segregated from motorised transport.
