Focused Local Plan Consultation Tuesday 5th July - Monday 25th July 2022

Following the Fareham Local Plan examination hearings, the Inspector sent a [Post Hearings letter](#) to the Council on the 6th June 2022.

The Post Hearings letter contained her findings on a range of matters relating to the Local Plan, including landscape, biodiversity net gain and housing supply. At the Inspector's request, the Council have prepared updates to three topic papers on housing supply matters to understand the implications of her findings.
