Whilst the timetable is subject to change it is currently anticipated that the Hearing Sessions will take place in Spring 2022. They are likely to last approximately 3/4 weeks with a break in between. It is uncertain at this stage what format the hearings will take, as account will need to be taken of any restrictions due to the Covid-19 pandemic. The hearings could be held face to face, virtual, or a mixture of the two.

The Inspector has been undertaking their initial assessment of the Local Plan, including legal compliance and soundness having regard to the submitted documents, the evidence base and representations. This has raised some preliminary questions by the Inspector and the Council have been asked to make their initial response by 3rd December 2021. The Inspector's initial questions have been made available on the examination webpages. The Council's response will be added to the webpages following their submission. In the meantime, please do not submit any further information or representations unless asked to.
