1 Introduction

During the Welborne Plan examination hearing session undertaken on Friday 17th October on Issue 6: Education, Community and Health Facilities (WEL14 – WEL16) of the Welborne Plan, discussion took place between participants relating to the engagement that had taken place with the relevant health authorities and with emergency service providers. The purpose therefore of this paper is to set out how the Council has engaged with these bodies during the production of the Welborne Plan.

All consultation undertaken during the development of the Welborne Plan, including that with both health and emergency service providers is detailed in the Regulation 22.(1)(c) Statement (SD05). That document explains which persons and organisations were consulted and how they were consulted with, for both the formal and informal consultation stages.

The purpose of this document is to respond to the Inspector's request made during the Issue 6 hearing session for a table setting out the health organisations that were consulted with and how during the development of the Welborne Plan and a second table setting out the emergency service providers that were consulted with during the development of the Plan.

Both tables have been compiled and are presented at Appendix A (health) and Appendix B (emergency services) to this document. The results of the Council's engagement with these organisations are included in the Council's Infrastructure Delivery Plan (EV27, updated in EV28).

2 Health

In accordance with Regulation 2 of the Town and Country Planning (Local Planning) (England) Regulations 2012, the statutory consultee for health provision is the relevant Clinical Commissioning Group (which replaced Primary Care Trusts in April 2013). As such, the Borough Council has undertaken continued engagement with the Fareham and Gosport Clinical Commissioning Group through meetings, formal consultation and through their membership of the Welborne Standing Conference.

In addition and in accordance with the National Planning Practice Guidance, which states "*The first point of contact on population health and well-being issues, including health inequalities, should be the Director of Public Health for the local authority or at the County Council for two-tier areas*", the Borough Council consulted with the relevant Director of Public Health, Dr Ruth Milton at Hampshire County Council, as part of the Regulation 19 representations process on the Publication Plan.

Furthermore, as Appendix A shows, engagement has also been undertaken with NHS Hampshire, the Portsmouth Hospitals NHS Trust, the Southern Health NHS Foundation Trust and NHS Property Services, alongside a number of local GP Practices and community health services.

3 Emergency Services

In accordance with Regulation 2 of the Town and Country Planning (Local Planning) (England) Regulations 2012, the Borough Council formally consulted the Hampshire Police and Crime Commissioner on both the Draft and Publication Plan, whilst Hampshire Constabulary have been engaged through their membership of the Welborne Standing Conference.

In addition, both Hampshire Fire & Rescue and the South Central Ambulance Service were consulted with in 2012 as part of the development of the Infrastructure Development Plan Stage 1 Report (EV27). Both organisations were also consulted with on both the Draft Plan and the Publication Plan.

In addition, the Maritime and Coastguard Agency were also consulted on both the Draft Plan and the Publication Plan.
