




Sustainability Appraisal (SA)

It assesses the Draft Welborne Plan against a range of sustainability objectives.






How this relates to earlier consultation

SA consultation in May/June assessed **the major options** (SA Options Assessment)

For example:

- The location of employment Junction 10 or Junction 11
- The level of employment floorspace
- The split between offices and industrial/warehouse



This consultation SA Report looks back at the Draft Welborne Plan and assesses **the sustainability of the policy requirements.**

This consultation forms an interim stage between the Draft Plan and the Publication Welborne Plan.

Strategic Design Code

- A Strategic Design Code will be prepared for Welborne
- It will provide guidance on the design principles to help develop each phase of development
- It will set out what will be expected in respect of overall design quality








Purpose of the Code

- The Strategic Design Code will provide high level guidance for architects, designers and house-builders on the following;
 - The distinguishing features of the different character areas
 - Design of the primary routes/ streets
 - Edge and boundary treatments
 - Parking options



• The Code will include typical sections, and other relevant illustrative material



What it doesn't cover

A Strategic Design Code will help guide but not include details of:

- The design of buildings
- Layouts
- Architectural detailing window design etc.
- Specification of materials
- Planting/landscaping schemes







Process

There will be informal consultations with;

- The principal landowners
- Key bodies- HCC, Environment Agency, Natural England
- The Standing Conference

To be adopted as a Supplementary Planning Document (SPD)
