Whilst Hampshire County Council in its role as a public landowner support the proposed re-allocation of land at Heath Road, the Borough Council will also be aware that an outline planning application this site has recently been submitted for consideration by the Borough Council in response to the existing Local Plan Part 2 Policy DSP40 in order to support the delivery of the Borough's local housing needs. In order to be internally consistent with the planning application advice received from the Borough Council to date and the emerging draft Local Plan Policy, the County Council has the following comments:

It is noted that Draft Policy HA9 bullet point 3 states that 'Building heights shall be limited to a maximum of 2.5 storeys'.
