Buckland Development Ltd. (BDL) support the approach outlined in Paragraph 1.4 and the Background Papers 'Updating the Welborne Plan' and 'A Delivery Trajectory for Welborne'. The Welborne Plan has been the centrepoint for our Outline Planning Application submission and the principles and policies held within it have provided important certainty which have enabled our outline planning application proposals to be submitted. We continue to work positively with Fareham Borough Council (FBC) to deliver this important part of both the Adopted Local Plan and the Draft Plan 2036.

We also support the proposed revision of the development trajectories within the plan, which create some flexibilty of delivery to respond to market conditions. Notwithstanding this, BDL remain committed to delivering the trajectories outlined in our OPA, however the additional policy flexibility is welcomed.

Infrastructure Delivery Plan

Please comment below.

BDL would like to raise concerns regarding the proposed position on the Community Infrastructure Levy (CIL). Paragraph 2.7 of the draft Infrastructure Delivery Plan states that FBC do not intend to review their CIL Charging Schedule, and that this will remain in place. Currently, the CIL Charging Schedule does not permit CIL receipts being spent on Infrastructure within Welborne, however the Charging Schedule does not make Welborne CIL Exempt or Zero Rated. This creates a 'double charging effect' with Welborne being CIL liable and the policies of the Welborne Plan requiring comprehensive infrastructure contribution through Section 106. This has serious impacts on the viability of the development, and may lead to viability related policy provisions held in the Welborne Plan being activated in order to offset this factor.

Furthermore, the Welborne Plan at paragraphs 10.50 and 10.51 clearly commits to a review of the CIL Charging Schedule and the intention to make Welborne Zero Rated for CIL. BDL supports this position outlined in the Welborne Plan and requests this review is undertaken as soon as possible in order to ensure the principles of the Welborne Plan can be achieved in delivery.
